**ORDER GRANTING PLAINTIFF'S UNOPPOSED MOTION TO DETERMINE
CONFIDENTIALITY OF COURT RECORDS**

THIS CAUSE came before the Court on a motion made by the Plaintiff seeking an order sealing one or more documents contained in the court file. The general nature of the document is the Petition for Approval of Settlement of a Minor's Personal Injury Claim, filed on May 10, 2019. In accordance with the provisions of Judicial Administration Rule 2.420(e), the Court finds as follows:

1. The Motion to Determine Confidentiality is GRANTED and the Petition for Approval of Settlement located at Docket Entry #85 in the above styled matter, shall be removed from public viewing and sealed by the Clerk of Court.
2. This case arises from a claim for injuries sustained by a minor.
3. The motion is granted because confidentiality is required in order to:
 - (a) avoid substantial injury to a party by disclosure of matters protected by a common law or privacy right not generally inherent in the specific type of proceeding sought to be closed;
 - (b) comply with established public policy set forth in the Florida or United States Constitution or statutes or Florida rules or case law.
4. This order of confidentiality does not relate to the names of any parties to this litigation.


5. This order of confidentiality relates only to the Petition for Approval of Settlement at Docket Entry #85 in the above styled cause and does not relate to the entire case or the progress docket.

6. The degree, duration, and manner of confidentiality ordered by the Court is no broader than necessary to protect the parties to this cause and the interests identified in this order, and no less restrictive measures are available to protect the interests set forth above.

7. The Clerk of Court is directed to publish the order in accordance with Fla. R. Jud. Admin. 2.420(e)(4) as follows:

- (a) Within 10 days following the entry of the order, the Clerk of Court must post a copy of the order on the Clerk's website and in a prominent public location in the Courthouse; and
- (b) The order must remain posted in both locations for no less than 30 days.
