Step One

Clerk of the Court, Volusia County, Florida web address is www.clerk.org.

- **Click**  [Search Online Records](#)
- **Position** the mouse under ▼ **Case Information** in the blue section
- **Click on:** •Case Inquiry
- **Type** your name in appropriate box and **click** the accept button.

Type the case number in the appropriate field; or,

- To search by name click the drop down arrow in the Case Type field to select the type of case, Family, Probate, Civil etc. or leave blank to get all case types.
- Type the Last and First Name or the Business Name of the person or business for which you inquire.
- Click the mouse on the Search button.

- Select the individual tabs to get additional information on the case:
 1. Summary tab provides basic details about the case such as judge information and type of case.
 2. Docket tab gives a list of documents filed in the case.
 3. Event tab will tell you where the file is located at a specific moment in time. For example whether the file is in the office, checked out to the judge or just returned to the office.
 4. Litigant tab details the name of all persons, businesses and/or alias' of people involved in the case.
