## CONSENT ORDER REGARDING CONFIDENTIALITY OF COURT RECORDS

THIS MATTER came before the Court upon consent of the Parties, the Parties' Final Judgment of Dissolution of Marriage (Docket #34), and the Husband's Verified Motion to Determine Confidentiality of Court Records (Docket #32), and the Court, having reviewed the Court file and being otherwise fully advised, it is hereby

## FOUND, ORDERED AND ADJUDGED:

- 1. The Parties were divorced on August 5, 2020 pursuant to a Final Judgment of Dissolution of Marriage, which incorporated a Marital Settlement Agreement and Parenting Plan (Docket #34).
- 2. Pursuant to Paragraph 24 of the Parties' Marital Settlement Agreement, they agreed for certain dockets to be made confidential, including Docket #18.75, Docket #25, Docket #26, and any other docket entries containing financial or other sensitive information. In Paragraph 24 of their Agreement, the Wife also consented to the Husband filing a Motion to Determine Confidentiality of Court Records. The Parties also agreed there are sufficient facts/evidence to satisfy the standards in Rule 2.420 for the Court to enter an Order making the specified dockets confidential.
- 3. The Husband's Motion to Determine Confidentiality of Court Records (Docket #33) requests that Docket #s 18.75, 25, 26 be made confidential, along with the Marital Settlement Agreement, Final Judgment of Dissolution of Marriage, the Husband's Motion (Docket #33), and any Order entered regarding Docket #33. (The Marital Settlement Agreement and Final Judgment did not yet have docket numbers at the time of the filing of the Husband's Motion.)

- 4. The following docket entries are to be held confidential from the public:
  - a) Docket #18.75 (Wife's Financial Affidavit);
  - b) Docket #25 (Husband's Financial Affidavit);
  - c) Docket #26 (Wife's Motion for Psychological Evaluation);
  - d) Docket #30 (Marital Settlement Agreement with Parenting Plan);
  - e) Docket #33 (Husband's Motion to Determine Confidentiality of Court Records);
  - f) Docket #34 (Final Judgment of Dissolution of Marriage);
  - g) This Order (Not yet Docketed).
- 5. The type of case this Order is being granted is a Dissolution of Marriage matter. It is unnecessary that any Party's name is determined to be confidential.
- 6. The degree, duration, and manner of exempting the Civil Court record from public access is not broader than necessary and there is no less restrictive measure to protect the trade secrets of the place of the Wife's employment, a compelling government interest, or to avoid substantial injury to innocent third parties.
- 7. The exempt Civil Court records may be viewed by the Husband, Wife and Attorney(s) of record.
- 8. The Clerk of Court is directed to publish this Order in accordance with Fla. R. Jud. Admin. 2.420(e)(4).
- 9. The Court reserves jurisdiction for enforcement, modification, and clarification of this Order.
